SUBJECT: Chapter Activities Report

1. A meeting of the Chapter Activities Committee was held at 1130 hours on 22 July 2005 at the Intercontinental Hotel in San Juan, PR. See attached AGH Form 6-19, ANG NCOAGA SIGN-IN SHEET for members that were present.
2. The following items were discussed:
 - a. SMSgt Uthe explained the process for reviewing the AGH Form 6-5 to committee members and explained the three national awards: Operation Patriotism, Civic Actions, & Parade of Chapters.
 - b. Twelve packages were submitted and reviewed. Those reports validated for total activities/points were Chapters 7, 9, 10, 13, 19, 21, 50, 54, 56, 57, 70, and 93.
 - c. Four Pride Books were submitted and are on display in the Grand Foyer. Those chapters displaying their Pride Book were: Chapters 7, 9, 70, and 93.
 - d. Of the twelve packages, three chapters submitted Graduate articles. Those Chapters submitting articles included Chapters 9, 54, and 70.
 - e. Last year's committee minutes were reviewed.
 - f. Points were tallied and instructions were given to committee members that the tally results were to be kept in confidence until announced on **Thursday Sunday** at the formal Awards Banquet.
 - g. Additional discussion items involved the following:
 - Much discussion centered on the point value for Pride Books. A motion was made by CCMSgt Handel to remove the Pride Book out of the scoring matrix on the AGH Form 6-5, Parade of Chapters and add it to the AGH Form 6-6, Pride Thru Recognition Annual Report and AGH Form 6-7, Pride Thru Recognition Scoring Matrix. SMSgt Gianetto seconded the motion. Motions to make changes to follow.
 - The committee discussed and recommends Chapters publicize "Best Practices" on the NCOAGA web site under "How To" link. IT is also recommended a "Best Practice" Award and refers it to the Award and Memorial Committee for discussion.
3. There being no further business the meeting was adjourned at 1500 hours on 22 July 2005.
